The hirer has inspected the bike and accessories and they have familiarised themselves with the equipment before undertaking any journey.

1. The hirer agrees not to undertake any manoeuvres or journeys beyond their capability.
2. Electric Bikes Scotland accepts no liability or responsibility for any loss, damage or injury whilst in possession of a hired cycle. All patrons hire cycles at their own risk.
3. The hirer agrees to pay due care and attention to the security of the cycle, have the cycle locked and secure at all times when not in use with security lock provided to a permanent fixture e.g. lamppost, cycle rack, railing etc.
4. All bikes are fully safety checked and adjusted by a qualified cycle technician before hire commences.
5. The hirer agrees to return the bike in a serviceable condition. All damage and repairs which arise from neglect or misuse will be chargeable.
6. For group/corporate hire the lead person accepts responsibility for all hires undertaken within the group unless a separate hire form is completed by each individual. All individuals must be listed on the group hire sheet for hire to commence.
7. The bike and equipment is only to be used by the named hirer.
8. Electric Bikes Scotland must be notified within 24 hours of any loss, theft or damage.
9. The hirer agrees to return the bike and accessories at the end of the hire period, failure to do so will result in the hirer being charged a standard rate of £50.00 per day until the cycle is returned or alternatively the full retail value of the hired equipment to the card details previously provided.
10. The hirer agrees that the security excess of £150.00 for a non-electric bicycle/ £350.00 for an electric bicycle can be charged as a POINT OF SALE transaction to their card if the bicycle is lost, damaged or stolen as per the terms & conditions of hire.
